

PERSONAL DATA PROTECTION ACT 2010

NOTICE AND CHOICE

This notice is issued pursuant to the Personal Data Protection Act 2010 (“the Act”), which became enforceable on 24 May 2018:

PURPOSE(S)

1. to verify and process personal data or responding to requests such as theme park tickets, processing bills and payments, restaurants reservations and other requested goods and services and/or activities;
2. performing customer support and services such as promotional offers, theme park rates, newsletters, credit card payment processing and/or guest surveys
3. to communicate with the theme park guests via SMS, phone call, email, fax, mail and/or any other appropriate communication channels;
4. to notify the theme park guests of any changes to our products, goods, facilities, services and/or loyalty programmes which may affect the theme park guests via SMS, phone call, email, fax, mail and/or any other appropriate communication channels;
5. the theme park guests’ participation in lucky draws and contests conducted by us or on our behalf;
6. public disclosure and use of the theme park guests’ personal data, images, photographs, voice and video recording for publicity purposes without payment or compensation if the theme park guests become a winner in a contest;
7. to maintain our own accounts and records;
8. the use of CCTV systems for crime prevention;
9. to enforce contractual and legal rights and obligations; and
10. to meet legal and regulatory requirements.

(Hereinafter collectively referred to as the “Purposes”)

Please note that it is necessary for you to provide us with your personal data. Failure to do so may result in us being unable to process and/or disclose your personal data in relation to the Purposes. We may also keep your personal data for a reasonable period to enable us to contact you about our products, services and promotions in the future.

We may disclose or share your personal data, which were gathered from such information you have provided to us vide e-mail(s) and/or letter(s) and/or our various form(s) and/or websites, to our business partner and associates as follows:

3. any actual or proposed assignee, transferee, participant or sub-participant of Themepaktu Sdn Bhd's rights or business.
4. where required by law, legal processes, queries from the relevant authorities and/or matters relating to life, death, security, health or property of an individual or corporation.
5. the general public by publishing the theme park guests' personal data, images, photographs, voice and video recording for publicity purposes without payment or compensation if the theme park guests become a winner in a contest.
